### REGISTRY RULES

#### **RULE 7 Transfer of Record of Ownership**

To transfer the recorded ownership of a Registered horse, the recorded owner must submit a completed and signed Transfer Application, the official Certificate of Registration for the horse, and the appropriate fee. When applicable:

- A. The Certificate of Service portion of the transfer application shall be correctly completed by the recorded owner for the transfer of a mare bred before the date of sale.
- B. Any person applying for transfer of a horse may be required to furnish (at the applicant's expense) genotype reports, documents, or additional information the Registrar may deem appropriate.
- C. Whenever legal title of a registered horse passes to another person by reason of death of the recorded owner, foreclosure of any lien, by any order or decree of court, or otherwise by operation of law, the Registry may transfer the registration to the new owner subject to the following;
  1. Upon court order of competent jurisdiction or satisfactory proof of authority for the transfer.
  2. Upon payment of the transfer fee.
  3. Upon satisfaction of such other requirements as may be required by the Registrar.
